 - Dave Nelson suggested a YMCA/Y meet conversation needed
 - Georgia Androy noted that fees may be limiting kids' involvement
 - Brian Jensen's letter regarding YMCA clubs and meet approval was shared along with Jimmy's reply
 - David N noted that Ys have a different perspective and recommended tabling until next fall for fee increases
 - Stefanie noted that USA recommends higher fees; noted that Betty works Y meets as a volunteer

Sanctions/Meet Schedules-

MW 2024-2025 Short Course – All requested meets have been posted with the exception of the 13 & O Short Course Championship which should be posted soon.

MW 2025 Summer Meets –We have most of the summer requests and some of the 2025-2026 short course requests. The received requests have been sent to the sanction committee. The schedule has not been posted pending sanction committee. Bids for the Long Course 12 & Under and 13 & Over Championship meets are still needed. Email was sent to all prospective hosts requesting meet information, sanction application, and fees on January 12. One has been received. No bids have been received for the two long course championship meets. The 13 & O meet is scheduled for July 18-20, 2025 and the 12 & U meet is scheduled for July 26-27, 2025.

MW 2025-2025 Short Course – We have minimal requests for meets for short course. An email containing weekend lists as well as a list of meets that have been requested was sent on January 12 to every Midwestern Club head coach and club contact. No additional meet requests have been received.

- All Star Meet The All Star meet was held January 11-12, 2025 in Des Moines, IA. Midwestern sent 68 athletes and 5 coaches. Sam Bach was the head coach. Assistants were Mikara Feit, Paige Hunt, and Shane Ahrens. Paige Skidmore was the team manager. Midwestern placed 4th with 439 points. Dean Rasmussen of FAST placed 2nd in the 11-12 boys.
- Athlete, Outreach, Officials Reimbursements Total athlete reimbursement requested for national meets from September 1, 2023-August 31, 2024 was \$10,150 for 2023-2024 Winter Juniors, Westmont TYR Pro, Summer Nationals, Futures, and Columbia Sectionals. \$646.88 has been sent for Outreach reimbursement for the same period. GoogleForms for both Athlete Reimbursement and Outreach Reimbursement are posted and distributed to clubs. To date for 2024-2025 \$3000.00 has been requested for athlete reimbursement (Winter Juniors) and \$215.25 has been requested for Outreach. Officials' reimbursement for those officiating at national level meets was \$2429.79 for September 1, 2023-August 31, 2024.
- High School Swimming Iowa girls completed their season on November 16. MW will acknowledge times for any MW swimmers in the IA observed meets. IA Boys are currently in their season. Nebraska's HS season is in full swing. High School meets that are scheduled to be observed are the Conference meets and the State meet. Forms requesting observation will be required for all HS meets with names of at least 2 USA officials who will be 'observing'. Invitationals wanting observation must file a request with the MW office and MW Times chair. A minimum of two (2) USA certified observers must be present and officiating in the appropriate observation positions in order for the times from the HS meets to be used. At this point ten (10) invitationals have requested observation and the four (4) conference meets have requested observation. No request or information has been submitted for the Nebraska State High School Championship. (Assignments for that meet are not done until the end of January.) In order for times to be used athletes must be currently registered with MW and USA Swimming. To date seven (7) observed meets have been completed. Results from observed meets that have been put in SWIMS and the MW databases are posted on the MW website on the MW 24-25 SC Results page.

Agenda:

- 1. Approval of new Official Membership category (Junior Official). Presentation by Leslie.
- 2. Discussion/ Proposal of MWS Standards for CJ certification, as well as Open Water Certification
- 3. New officials' training/certification- Online vs Clinic. (brief, informal)
- 4. Proposal for end of season meets MR, AR/AO.
- 5. Athlete Rep to the Committee?
 - The MWS registrar submitted a proposal for approval of new Junior Official Category, as per USA R9 standards. Committee discussion, no issues identified. Proposal moved/ second Brailita/ Swartz. All members in favor.
 - Discussion re: Officials Committee elections. 2 open positions for 2025: S. Kidder (
 eligible for reelection), Omaha position, as well as K. Olberding, at-large, eligible for
 reelection. Discussion about election procedure. It was agreed that the election will be
 electronic through google form, and votes will be tabulated by MWS. Officials thanked
 the current committee members for their service.
 - The Officials Chair will send note for nominations with a 1–2-week timeline; with a 2nd ballot to be sent to all officials when nominations are closed.
 - The Officials Chair informed that many LSC's offer standard CJ certification. In order to enhance officials education, run efficient high level meets, keep consistent with other LSC's, as well as to make sure our nationally certified CJ's will be able to recertify in the future, it is necessary to consider adding an LSC CJ (chief judge) certification. All members were in favor. Discussion ensured re: qualifications. There are R9 standards which are to be followed. Char asked for volunteer task force, and S. Kidder volunteered to draft guidelines. The chair will verify draft and make sure it is consistent with R9 and LSC needs before submitting for approval.
 - RE: open water standards, S. Kidder also advocated for LSC certification. Members were in favor. Officials that already attended an open water clinic and open water meets over the last 5 years may be grandfathered in if they meet current USAS requirements. Draft will be sent to MWS, with goal to start this LSC certification prior to summer.
 - Regarding end of season meet- discussed potential candidates for meet referee vs admin referee, and need for training new / younger people in this capacity. OC explained requirements for a meet with evaluators, and preference for DR N2 as MR for the meet, unless National Evaluator is present. OC asked for nominations for future MR apprentice for Championship meet. It was agreed that Ogura, Howard should be offered next

opportunity; Hoesing, Olberding have been offered opportunity but unable to MR at next meet. OC will continue to discuss individually and identify candidates. It was agreed to assign MR and AR for next meets blending pool of experience with new trained/ willing MR AR.

Chief Judge (CJ)

The LSC is offering an opportunity for advancement and additional certification as Chief Judge (CJ). CJ Certification is not required to act as a CJ at a meet. Certified CJs will be used in the role when possible, but if they are not available, Stroke & Turn judges (ST) may be used as CJs.

The Chief Judge serves at the direction of the Meet Referee as a peer to the Deck Referee. The duties include management of the Stroke and Turn Judges, the investigation and recommendation of disqualifications for acceptance or rejection to the Deck Referee, and to manage equipment which may be needed during the session.

1 Qualifications & Education: – The Chief Judge:

Must be certified Stroke & Turn Judge

Minimum Age 18

Sixteen (16) or more Sessions as certified ST.

Attend a CJ Clinic OR briefing of CJ duties.

Have read the CJ Professional documents.

Apprentice as CJ for four (4) Training Sessions at a minimum of two (2)

meets with a Trainer(s)

May officiate in any LSC meet.

For Certification: needs to document Apprenticeship signed off by a Certifier. Recommend that this must include successfully giving the stroke briefing for at least one (1) session while evaluated by a referee, as well as passing the CJ online test.

Needs to apply for certification through LSC Officials Chair.

2. Recertification:

Work eight (8) Sessions per year with at least four (4) as a CJ or Referee. Pass USA Swimming recertification test every three (3) years for the highest certification held.

Document Satisfactory Performance as Chief Judge

3. If a member currently holds an active national certification (N2 or N3) for CJ, the Chair can waive the above initial requirements to certify the Member as LSC CJ since the National Process involves satisfying all the initial certification requirements. All subsequent recertification shall follow the process as outlined.

MWS Open Water Certification Proposal:

We propose that LSC officials that have met the below requirements in the last 3 years, are eligible and should apply for certification for open water. The certification request should be made through the officials chair. An officials chair designee (with initial experience in open water/ certification as open water official) may handle requests on behalf of the officials chair.

OPEN WATER JUDGE (Minimum Age 18*)

(includes Turn, Finish, Timer,

Feed Station Judge, and Recorder)

Education & Training Should pass USA Swimming Open Water Judge

> test with a score of 80% or better prior to attending an Open Water Clinic/Event.

Must attend a pre-race briefing.

It is recommended to have an apprenticeship at an Open Water event with at least one mentor (who has a minimum of one (1) year experience as Open Water Judge) in any Open Water Judge

position for a minimum of one (1) event.

Evaluation & Certification Evaluation by evaluator/mentor and/or Open Water Referee to be reported to LSC Officials

Chair or their designee.

Must be a member of USA Swimming, pass the Level 2 Background Check, and complete the online Athlete Protection Training before

Must apprentice on the water with a certified Open Water Referee/Starter for a minimum of one (1) Open Water Event.

Certification based on recommendation of the trainer(s) and/or Referee(s)

Require score of 80% or better on recertification test every two years.

To maintain certification, must work a minimum of one (1) Open Water Event every three (3) years as Assistant Referee, Administrative Referee, Referee, or Starter. Based on continuing USA Swimming membership and evaluation by the LSC Officials Chair or their designee.

Evaluation & Certification

Renewal

Wording for 4.10.6 and 8.2.5.8 received from the Governance Committee with the caveat that some changes may still be necessary.

4.10.6 Penalties for Invoices not paid in a timely manner: (03/19/24)
Invoices not paid within 30 days will incur a late fee of \$25.00.
Invoices not paid within 60 days will incur a late fee of \$50.00
Invoices not paid within 90 days will incur a late fee of \$100.00
In addition, teams with unpaid invoices 90 days and beyond upon notification from the registration chair and approved by the Executive Committee will be subject to unattach status for all athletes which will entail payment of transfer fees for all athletes to reattach.

Transfer fees that have not been paid are the direct responsibility of the individual athlete, not the club to which the athlete is transferring. Such transfer athletes may not compete as part of a club membership status until all fees are current.

8.2.5.8 Penalty for Unpaid Invoices and Meet Fees: Midwestern Swimming clubs with unpaid MWS invoices or unpaid meet fees owed to host clubs shall not be permitted to enter a MWS 8 & Under Championship meet, a Challenge Meet, or a Midwestern Championship Meet as members of their a club. Athletes may enter the Challenge Meets or Midwestern Championship Meets as UNATTACHED. Meet entry deadlines will not be extended for teams with unpaid invoices or meet fees and athletes will be Unattached for the entered meet. Host clubs must alert the LSC MWS Office and General Chair of unpaid meet fees. (Unattached athletes are not permitted to swim on relays. USA Swimming Rule 102.3.1). MWS Registration will change all attached athletes to unattached status of clubs that are not current with all fees. All such unattached athletes will be responsible for meet fee payment directly to the host club or the MWS Office as per the meet flyer.
