- **Sanctions/Meet Schedules–**

MW 2024-2025 Short Course – The tentative schedule of requests for the 2024-2025 Short Course season is posted. September and October meets have been sanctioned and posted. November and December meets are in the hands of the sanction committee. As clubs register for 2025, documents are filed, and sanction committee approves, January – March meets will be posted.

MW 2025 Summer Meets – A request for bids for Summer 2025 and Short Course 2025-2026 was sent to ALL MW clubs. Weekend dates for the year along with holidays and meets already requested were included in the email. Those requests were due June 1, 2024. We have most of the summer requests and some of the 2025-2026 short course requests. The received requests will be sent to the sanction committee.

MW Ad Hoc Meet Committee – This committee met and put together tentative meet formats for the 13 & Over and 12 & Under Championship meets for 2024-2025, both short course and long course. The 12 & Under meet will be a three-session meet and include 8 & U athletes to be held February 22 and 23, 2025. The 13 & O meet will be March 7-9, 2024 – 2 ½ days, TF on Friday evening, P/F on Saturday and Sunday. We have bids for both meets. The committee is recommending some changes to time standards and fees for these meets.

- **Zone Meet** – The MW Zone team consisted of 43 athletes and 4 coaches. Meet was held in West Fargo ND. Midwestern placed 5th with 1333 points. Anthony Miles, Ryan Korthals, Megan Ziemann, and Paige Skidmore served as coaches. Betsy Purcell of MW was meet referee.
- **Athlete Reimbursement and Outreach Reimbursement** – Tracking for annual reimbursements begins with September 1. To date MW has sent \$10,100 for Winter Juniors, Westmont TYR Pro, Summer Nationals, Futures, and Columbia Sectionals. (Last date for filing for Long Course is September 30.) \$646.88 has been sent for Outreach reimbursement. GoogleForms for both Athlete Reimbursement and Outreach Reimbursement have been posted and distributed to clubs.
- **MW LEAP** – The 2024 LSC Evaluation and Achievement Program requirement for MW is due September 30. We have the template for completion and an outline of the items that need to be addressed. A tentative document is mostly completed with the narrative for a few items still to be completed.
- **USA Swimming ABM and Workshops** – Midwestern will send several members to the meetings in Denver Sept 26-29. Workshops include those for General Chairs, Coaches, Officials Chair, Registration, DEI. MW is allowed one non-coach non-athlete vote along with three coach votes. Betty will have a Central Zone vote.
- **High School Swimming** – Iowa girls are now in their HS season. MW will acknowledge times for any MW swimmers in the IA observed meets. Nebraska's HS season will start November 18. High School meets that are scheduled to be observed are the Conference meets and the State meet. Invitationals wanting observation will be required to file a request with the MW office and MW Times chair. A minimum of two (2) USA certified observers must be present and officiating in the appropriate observation positions in order for the times from the HS meets to be used.

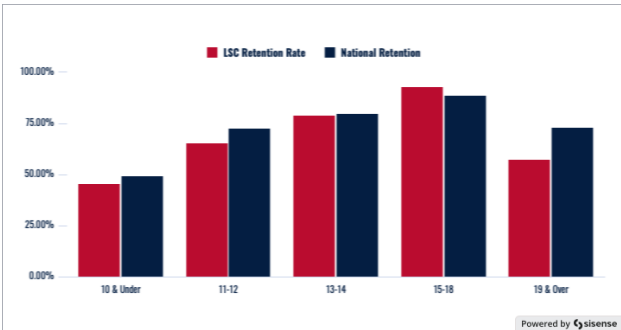
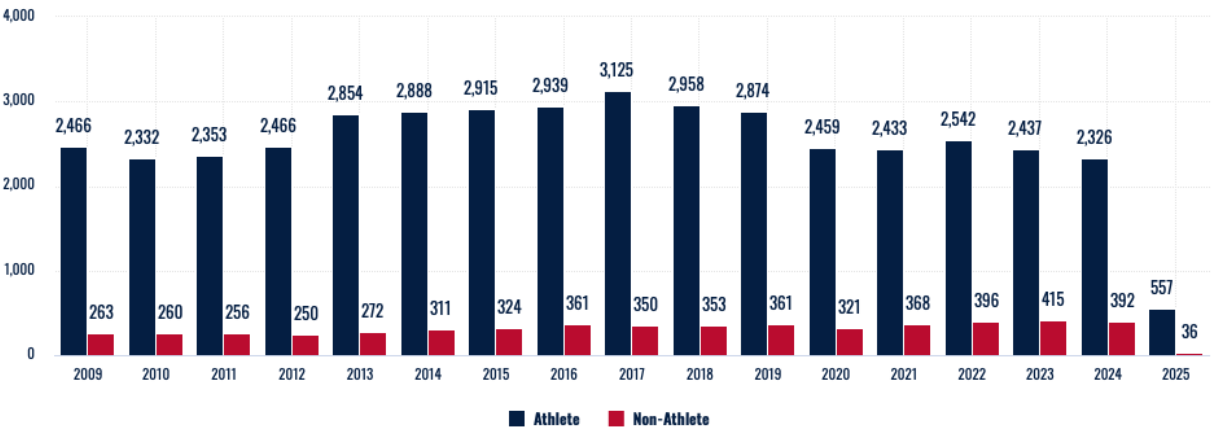

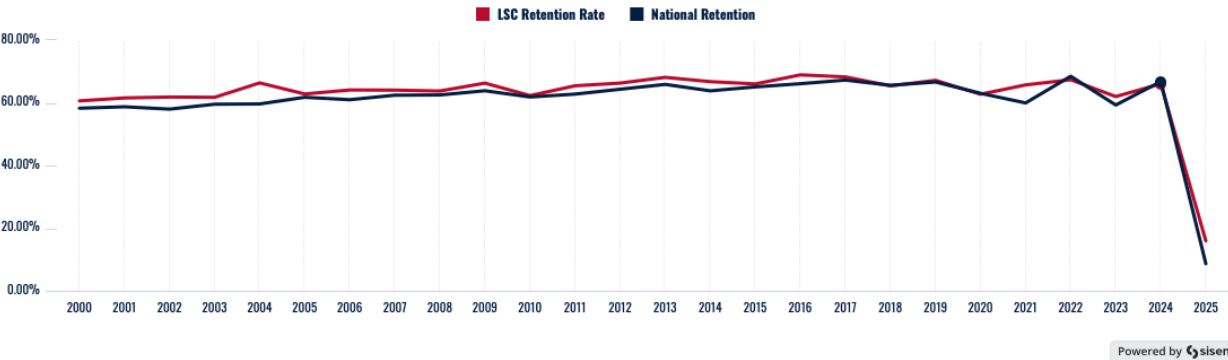

Changes to the MW Policies and Procedures

September 17, 2024 Board of Directors Meeting

From Ad Hoc Championship Meet Committee:

Rationale for 8.5.5.2 (g)

Costs for hosts and facility fees have been increasing continually. The committee felt that it would be better to give the MW Sanction/Scheduling/Technical committees the option for setting the fees for the Championship meets on an as-needed basis rather than locking in event fees permanently.

8.5.5.2 (g)

Midwestern Championship meet – Midwestern will approve and purchase awards and will receipt all entry fees for the meet. MW will retain the MW surcharge, any fines, and cost of awards. MW will forward remaining funds to host. Host club may choose vendors and meet apparel designs for merchandise, Host will pay all other associated expenses and will retain program revenues, concessions revenues, advertising revenues and commissions from sale of meet apparel. (09/09/14)

~~\$6.50/maximum individual event~~

~~\$18.00/maximum charge per relay event~~

MW will set the fees for individual and relay events and facility fees if necessary

\$6.50/MW surcharge (04/21/18 – in effect 09/01/18)

\$3.00/per session or \$16.00 complete weekend maximum program charge

Rationale for 8.2.5.6

Since Covid, MW has had to veer away from the calculation of the qualifying time formula (used since the late 90s until 2018) to something less stringent to get enough participation in the meets to make them financially viable. We (MW) agreed to set the 12 & U at a minimum NAG B time standard and the 13 & O at a minimum NAG BB time standard for the last several MW championships, at some point using an Automatic and a Secondary qual time. For the last two years we have used the Secondary for minimum entry and the meets have had the numbers needed. The committee feels that option should be given to the Sanction/Scheduling/ Technical committees to modify the qualifying times for these meets in the event that the B and BB times no longer make the meets viable. It is the hope to hold to the 2025-2028 NAG B and BB for the next quad (with time for the distance events being set differently), but that may not seem reasonable and the qualifying times may need to change.

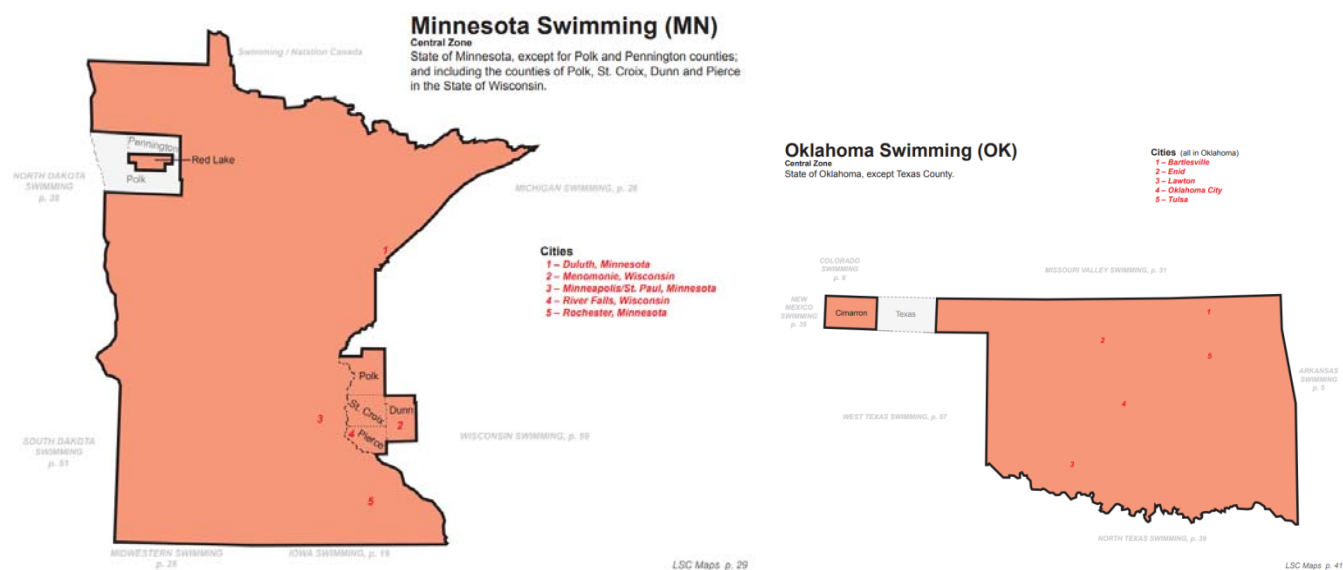
SWAT wishes to use USA Swimming rule 604.2 and to have Woodbury county in Iowa added to the Iowa LSC.

604.2 CHANGE IN LSC TERRITORY — If two-thirds (2/3) of the number of clubs in a contiguous area within an LSC wish to affiliate with a neighboring and contiguous LSC, and should the House of Delegates of each LSC by a majority vote of the members present approve the change, the change in territorial jurisdiction shall include all Club Members in the contiguous area and shall become effective no sooner than sixty (60) days following the receipt by the Chair of the USA Swimming Rules & Regulations Committee of satisfactory evidence of the various votes required. Club Member approval of change in affiliation shall be in accord with the rules of the Club Member and shall be duly certified by the Club Member's president and secretary.
